Since 1976, the federal Hyde Amendment has protected taxpayers from being forced to pay for other people's abortions. It has been included in every federal budget for more than four decades. Supreme Court Takes Up Mississippi 15-Week Abortion Ban

In a monumental announcement, the U.S. Supreme Court decided to take up a case involving Mississippi's new ban on abortion after 15 weeks of pregnancy.

The case, *Dobbs v. Jackson Women's Health Organization*, is a direct challenge to *Roe v. Wade*. In granting the petition to hear the case, the Supreme Court said it will address the question about "whether all pre-viability prohibitions on elective abortions are unconstitutional." 2020 Michigan Abortion Report Summary

The 2020 Michigan abortion report is no doubt very troubling. The 8.5% increase to 29,669 induced abortions from 27,339 reported in 2019 is the largest true increase since 1987 (not counting the 2013 report after the Prolife Omnibus Act forced out several non-reporting abortion facilities).

Numbers for women having abortions who already had a child continue to increase, up to 66.9% in 2020. These women represent a steep challenge, already understanding what pregnancy entails and most experiencing a high-quality ultrasound appointment. Black abortions continue a tragic and sustained increase. Looking at the abortion rates by race and age, the Black abortion rate is astronomical in Michigan. The Black abortion rate is between 6 and 7

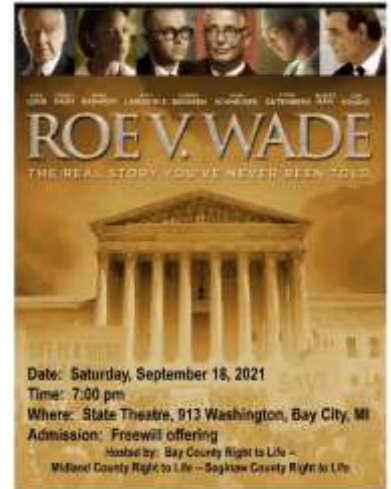
40 Days for Life - 5th Annual Fall Campaign
